

CAREWare User License Agreement (Modified October 2019)

Attention: This is a license, not a sale. This license is granted by Jeff Murray's Programming Shop, Inc. (jProg) and may not be modified or amended by anyone or any entity other than jProg. This Product is distributed as freeware, but the Product is protected by U.S. copyright laws and international treaties.

2. License:
